### Healthcare Laws Every Provider Should Know: 2022 Update

The laws and regulations impacting healthcare providers and consumers are constantly changing, both at the Federal level and within our State of Georgia. Our 2022 update will look at the changes in the legal landscape due to the lingering COVID-19 pandemic with a special focus on the legal implications of federal and workplace vaccine mandates.
